Dear Madam,

Your application of 19.11.2015 for the registration of the disinfectant "Dezotek Med" was reviewed at the Legal Entity of Public Law L. Sakvarelidze National Center for Disease Control & Public Health, in particular: 1. Information of the scope, rules and conditions of use of the disinfectant; 2. Origin and safety certificates issued by the authorized body of the manufacturing country; 3. Report on the disinfecting effect of the remedy. Based on the submitted documents the following is established:

The disinfectant Dezotek Med has the antimicrobial effect against gram-negative and gram-positive microorganisms, causative agents of tuberculosis, viruses (including acute respiratory disease agents, herpes, polio, all hepatitis, including hepatitis A-, B- and C-, HIV-infection, APC virus), Candida family fungi and trichophyton (dermatophyte), molds, healthcare associated infections, has the sporocidal action, and is effective against the causative agents of especially dangerous infections (plague, cholera, anthrax).

The remedy does not damage the treated objects, does not discolor fabrics, does not fix organic contamination, does not cause the corrosion of metals. The working liquids are not inflammable, are fire and explosion safe, ecologically safe. The remedy is incompatible with soaps and anionic surfactants.

Method of use

Dezotek Med is a transparent liquid from colorless to yellow color. The shelf life of remedy in the manufacturer's package is 3 years. The open life of the remedy is 14 days. The working liquids for disinfection and sterilization are prepared according to the manufacturer's recommendations and type of the equipment used, technical data and the manual. The surfaces of premises (floor, walls and so on), furniture, equipment are cleaned with the wipers wetted with the remedy solution. The surfaces are also cleaned with the brushes wet with the remedy solution. It does not require washing off after disinfection. The use of Dezotek Med for disinfection along with the pre-sterilization cleaning, of medical tools and equipment, high-grade disinfection of endoscopes and sterilization of medical items is allowed only in compliance with the user's manual provided by the manufacturer.
